6. **Association Business**

RAM Waste

Terry Putman reviewed the terms of the RAM Waste renewal contract with Management and the Board. 95 gallon trash bin will be \$55.10, 65-gallon bin \$35.00, and 35-gallon bin to be \$10.15. This contract will be in place of the otherwise mandatory Fort Collins citywide usage of Republic Trash services.

Clydesdale Estates Water Contract

Terry Putman relayed to the Board his most recent discussion with the Board of Directors at Clydesdale Estates regarding the sale of water by Clydesdale Park HOA. Management will work on retyping the contract rather than converting the old contract from PDF to Word format.

Carriage Parkway Plans

The Board reviewed the City's plans to paint traffic stripes on Carriage Parkway, as well as adjusting the stacking in the turn lane at the Highway 14 community entrance.

2023 Budget Approval

Management and the Board discussed the 2023 Proposed Budget; Management will supply quotes for a 3rd-party audit of the community's finances, and relay to the Board how carryovers/deficits are displayed on the financial reports.

<u>Insurance Renewal</u>

Management reviewed the insurance renewal proposals with the Board, as provided by the current carriers and AIAI. The Board requested that Management further detail the purpose behind carrying Crime Carrier coverage; the motion was made to dispense with Crime Carrier portions of the insurance quote if possible, and seconded and passed unanimously.
