### 3. Secretary's Report

An increase to Water Reimbursement (income) to reflect actuals 2024, and Sprinkler and Irrigation Repairs. The surplus income 2024 added to Reserves. After discussion, Robert made a motion to accept Financials, the motion was seconded by Justin.

- Terry mentioned the "Architectural Guidelines for Tenants". This document will be provided to Homeowners for their Tenants. It provides an overview of specifications of the Declaration of Covenants, Conditions and Restrictions. This will be reviewed again by the Board at the January 7<sup>th</sup> meeting.
- Terry stated, no project recommendation in 2025 from the HOA Survey.

- The delay in Pond 4 pump and filter replacement is set to be completed Spring 2025. Quality oil upsizing pump 4 from 4" to 6" for two zones/clock, revisit January 2025 meeting.
- Terry mentioned Grande Vista water usage has increased, possibly consulting with them on water conservation.
- Terry provided a sneak peak of the PowerPoint Presentation for the Annual Meeting on November 6<sup>th</sup>.
- Mills will perform blow outs/ water shutoff on October 15<sup>th</sup>, 2024.
